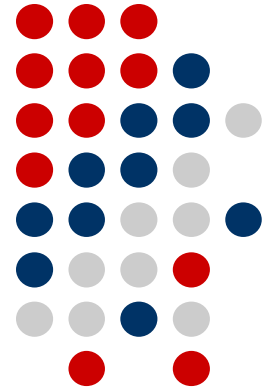
1. Taking responsibility as we resolve issues and improve the bottom line
